- IV. Minutes from previous BOD meeting –

Motion to approve minutes from meetings of 12/17/2018 and 01/28/2019 by Roberta Woods, seconded by Bruce Brazil. Motion carried.

#### **V.** Member's Reports & Requests

A. Butch Meyner – (see email attached) Butch has concerns about legal challenge asking for closure at Carnegie SVRA with the challenge by the wealthy Garmendi family. Butch would like a letter generator from CORVA. He knows that the family has the right to challenge and ask for the closer of the area. However, Butch wants to know why our legislatures spend their time and our tax dollars working on this issue when it should not be handled this way. Butch feels that maybe Garmendi/Connelly are donating to the politicians' campaigns and that's why they are prioritizing this challenge and the lawsuits from this family. Bruce Brazil reviewed the lawsuits and reports that our State Attorney General is fighting this in an excellent manor. Diana Mead will work on a letter so the people that live in the District 11 of Senator Glazer can send letters to his office. She also wants off road users in Senator Rebecca Bower-Kagen's district. These would be direct constituents and their voices (and voting power) mean more. We need the constituents from Senate district 7 and Assembly districts 11 and 16. Butch wants to use the internet to reach them. People can call and attend meetings. Lori Lewis wants to put notices on Instagram.

Nick Boeuet the FaceBook manager for the CORVA page with reach out to Ian (the new Instagram manager for CORVA) to coordinate messages to our members.

VI. **President's Report** — Ken Clarke — (see email attached) Ken reviewed the San Mateo 4WheelParts Truck Fest. The CORVA booth brought in about \$800.00 over the two days. The booth featured the new large banner that was made by Ed Waldheim's team for the Off Road Hall of Fame. Ken reports that many people stopped to read the banner. Ken also handed out the new CORVA flyers. Vinnie Barbarino remarked that while he was at Truckhaven Ed Stovin told him about an error on the banner and the flyers. There is a picture that misnames one of the people in the picture. It is listed as "Ricky Thompson" instead of "Ricky Johnson". Corrections will be made. Ken wants to use the flyers as a sales tool to businesses. Ed will have the corrections made on the flyers and enlarge the font before the next printing. Ken also thanked all the volunteers including Lori and Mark Lewis, Bruce Brazil and Bruce Landfield from BESTOP who helped. CORVA is invited again next year.

Ken wants to figure out plans for our annual meeting which will include elections. He also wants us to bring in more volunteers. The date is still in question. Locations suggested are Oceano Dunes or Jawbone again. Ed Waldheim reported that Jawbone is fine for Sunday April 28<sup>th</sup>. Ed suggested breakfast, lunch and dinner could be done in the warehouse/kitchen. Ken will call Ed. Lori spoke to the people at Oceano Dunes. That room only holds 25 people without tables.

Ken mentioned that maybe we could use a Collaboration App to help us all connect with each other better.

- C. Bruce Brazil reported that US Senator Murkowski has a large omnibus Bill S47 concerning many outdoor areas. The other US Assembly Bill HR403 concerns Clear Creek does not seem to be moving. Bruce suggested that it be added to S47 but has not heard back.

#### **VIII.** Finance Report

Treasurer's Report. Mike Moore – (*Financial Reports to be sent via email*) Mike reminded everyone that our yearend is February 28<sup>th</sup>. Mike needs everyone to give him an inventory of CORVA items they have so he can make adjustments before turning in our Financials to the CPA for our tax return. Mike turns our information in by April 1<sup>st</sup>.

- IX. **Northern Report** Lori Lewis reported on her participation with the booth. She wants Mike to let us know if we get members from that area because people said they were going to join. There were also many Overlanders at the event. Ken reported about the Rubicon Trail Foundation fundraiser Black Tie and Boots event coming up in March in Jackson, CA. (Board members pay their own way.) CORVA is participating in the Eldorado and Tahoe Forest Over Snow travel management. People who didn't originally write comments were submitting objections on the plan. Amy is going to question how this is possible. Bruce Brazil added that he worked the booth and it was the first time he did. He had many people tell him how great CORVA is. Vinnie said memberships are important to get during events, not just donations into the donation box.
- X. **Southern Report** Vinnie Barbarino *(see attached report)* There are two events happening in March, both on the same weekend March 23-24<sup>th</sup>. Vinnie will be working the EcoKrawl in Ontario and SDORC will hopefully represent CORVA and off road interests at the Del Mar event. Next year hopefully, we will be represented at both events. The goal is to get memberships at either event. Vinnie will make sure to send Ed Stovin some of our newsletters. Vinnie will need volunteers. Continuing, Vinnie reported that Charlie Lowe will attend the IE4W meeting and accept the donation to CORVA from the matching funds program. Vinnie also reported that the raffle donors from Truckhaven were sent thank-you letters and t-shirts. Additionally, Stephen Howard (Scooter) sent pictures of the raffle winners to the appropriate vendors. Vinnie agreed with Jim Woods that the Annual Meeting be held on Sunday April 28<sup>th</sup> so that we can participate in the Moose Anderson Days. (See Ed Waldheim's comments above.) Ed Waldheim reminded everyone of the OHV Commission meeting on Friday March 1<sup>st</sup>. Redrock will be the main focus of the Commission visit and discussion. Ken asked as many people as possible to attend. The State historians took information from Ed and Bob Ham about the 50 year history of CORVA.

A. CORVA Annual Meeting 2019– The date will be Sunday April 28<sup>th</sup> at Jawbone Station. Our meeting will be in the shop area on Sunday. More details about the food etc. to come. Ken will send out an email. B. CORVA 50<sup>TH</sup> Birthday 2020 – sub-committee needed to create budget, etc. – Ed Waldheim mentioned that the State Historians are also working on a 50<sup>th</sup> anniversary of OHV in California as well. They took all of Ed's information to Sacramento to create a history of OHV. Ken Oyer reported that he went to the hotel in Jean, NV where the CORVA OHV display is located. They want to host our 50<sup>th</sup> anniversary. There was some agreement to hold our event there. Ken Clarke wants our business sponsors to help pay for this. Lori Lewis agrees with holding the event there. More discussion to follow.

- C. Family Fun Run Event Pt. Mugu 4x4 Club Terry Work reports that Pt Mugu has been working with Hungry Valley staff to make the arrangements and get the permit process started. Pt Mugu will be there March 22-24 for a pre-run. The event will be family friendly and include all off-road vehicles. The event date is August  $17-18^{th}$ .



#### **REVIEW:**

Reports were attached

Truckhaven final – final invoices are in – net income was only \$600 off from last year which is fantastic considering we had no store and last year we took in \$1,650 from the store.

Our tax year is coming to a close – it ends on Feb 28 – it was a good year for CORVA – Donations were down (donations to the various legal funds were even and we still have the \$5,000 donation from IE4W which will show up the first part of next year but general fund donations were off around \$8,000) – Merchandise income doubled showing an almost \$7,000 increase and membership income was up over \$15,000 – (8 to 9,000 can be attributed to the increase from 30 to \$40 but there was growth in overall membership as well) – we still have another week in the year so should have a final for the year at the March meeting.

With our yearend approaching it is tax time – I have already reached out to Steve Gardner to provide an inventory update of what he has on hand for the store – any of you that are holding merchandise related to the CORVA store please give me an update of what you the first part of March so I can get an estimate together for the year end value of our inventory before the final accounting goes to our CPA for filing taxes.

Has anyone put together a document asking our community to contact their state senators and assembly members to contain the financial waste perpetrated by Celeste Garamendi and her pals? I've been meaning to write this up since the SRI Closure, and finally threw this together. I am not positively sure of all the facts, so all your corrections are appreciated. Plus we need to put in links to "find your representative" things. Or letter generators. Something to make it easy. And I think the timing is critical, as folks have a short attention span. Maybe when AB1316 Version 2.0 is introduced.

### Something like:

Please contact your representatives (go to this linky blah blah blah) and inform them that you would like them to oppose the continuing waste of the state's resources in her personal vendetta against OHV users? It seems a personal issue as well as a perceived economic one, as he husband owns a 7500 acre ranch adjacent to the Stave Park.

Through her family wealth and political influence, Garamendi has been able to have legislation introduced and lawsuits filed to cause the state to expend tremendous amounts of money to continue to operate this State Park that has been serving the community since 1974.

- The few assaults upon the OHV community and State Park that i am aware of are The Fisherman's Lawsuit of 2008
- Four lawsuits filed by her compatriots challenging the latest General Plan approved in 2016; "Friends of Tesla Park", SPRAWLDEV", Alameda County Parks and the Connolly Ranch
- 3 SB 249, meant to eviscerate the OHVMR Division of State Parks
- AB 1316, meant to force the State to give away two thirds of the park territory to SPRAWDEV, or some other entity which she has influence
- 5 Closure of the SRI creek crossing under the guise of the Connolly Ranch will lose access to their property because of physical destruction of their easement
- 6 The upcoming legislation to reintroduce the content of AB1316

Because almost anyone can put anything on the internet, Garamendi has continued to misrepresent the nature of the OHV activity at this, and other SVRA's. In reality, these parks are nature preserves that are well managed that provide critical facilities for this community of public land users.

It is ironic that the Garamendi and Connolly families have been operating incredibly destructive cattle ranching operations for more than a century.

I ask you to represent my communities' interests, as opposed to that of a few wealthy enraged individuals. They may have more money, and Connolly is a lawyer, but we are more voters. We do not have a lot of money, and the Garamendi tactic seem to be to continue to put up roadblocks until our community and the State run out of money.
